The Master of Business Administration (MBA) at IIT Roorkee is a regular residential program spread over two academic years divided into eight terms. The course structure is designed to impart knowledge of the core management concepts and techniques in the first year and advanced knowledge and practicing skills in the areas of specialization opted by the students in the final year.

## 2. NUMBER OF SEATS

---

The number of seats available in the MBA Program (through CAT) is presently 95 (Seats may be increased subject to approval of the competent authority).

Seats for IIT Graduates (admitted through IIT-JEE) may be supernumerary subject to approval of competent authority.

### 3. ADMISSION CATEGORIES

---

#### 3.1 Regular Candidates:

##### a. Through CAT 2025

##### b. IIT Graduates (Admitted through IIT JEE)

Final year students of any undergraduate programs who have completed the requirements of qualifying examination can also apply. In case of non-availability of the marksheets of final examination at the time of the Interview due to delay in the announcement of their results, candidates may be allowed to appear in the interview on the basis of their aggregate results upto pre-final year in which the percentage should not be less than as specified in section 3 under essential requirements. However, they will be required to submit the proof of having passed the qualifying examination with the required percentage or CGPA at the time of registration.

#### 3.2 Golden Girl Scheme for Female Applicants

Direct admission for female candidates under ‘Golden Girl Scheme’

- a) **Eligibility:** FIRST Rank holder (Gold Medalist) female candidates in qualifying examination from an IIT and/or Institute/university within the Top 50 ranks (overall category) in the NIRF in the most recent year.
- b) **Relaxation:** The requirement of qualifying an All-India Level Exam shall be EXEMPTED. However, all other MEQs will be applicable as per the institute policy.
- c) **Intake:** Intake shall be supernumerary.

**Note: Appearing candidates in the qualifying degree will not be considered under this scheme.**

#### 3.3 Full-Time Sponsored Candidates

The candidates must have a minimum of two years of full-time work experience in responsible capacity in a Registered Firm/Company/Industry/Educational and Research Institution/Govt./Quasi Govt./ Autonomous Organization in the relevant field in which admission is being sought. The Firm/Company/Industry shall either be a public sector undertaking or a public limited company registered in a stock exchange or a private concern whose annual turnover during the past two years exceeds Rs. Five Crores. The Educational Institution should be recognized by AICTE/UGC/Competent Authority.

### 3.4 International Candidates

International candidates who fulfill the eligibility criteria mentioned in point 3.1 may apply as per the procedure given in point 6.1.

International candidates who are neither IIT graduates (admitted through IIT-JEE) with a CGPA 7.0 or above on 10 point scale nor having CAT-2025 score, are requested to visit the website of International Relations, IIT Roorkee <https://ir.iitr.ac.in/> for relevant information towards application submission, registration, fee structure, accommodation, etc. Admissions of International candidates are processed separately from regular MBA seats.

## 4. ADMISSION ELIGIBILITY CRITERIA

---

(i) Graduation or a professional qualification equivalent to that of University degree recognized by UGC, in any discipline with minimum 60% marks (55% for SC/ST/PD) with CAT 2025 score. Final year students are also eligible to apply. Such candidates, if selected, will be admitted provisionally, provided they complete all requirements for the qualifying degree with minimum percentage and CGPA or its equivalent by the specified date that will be intimated later. The percentage will be considered on the basis of aggregate marks/CGPA awarded in qualifying degree examination.

OR

(ii) IIT graduates (admitted through IIT-JEE) with a CGPA 7.0 or above on 10-point scale are exempted from the requirement of CAT 2025.

## 5. ADMISSION PROCEDURE AND CANCELLATION

---

### 5.1 Interview and Group Discussion

A certain number of candidates shall be called for Group Discussion and Interview. Call letters shall be sent to the shortlisted candidates through email. This list will also be available on the department webpage.

Offline interviews are likely to be held at Roorkee, Greater Noida, Bengaluru and Kolkata. We strive to provide candidates with their most preferred location, but the final venue of the interview may differ from their top preference, depending on various factors.

## **5.2 Documents required at the time of Interview:**

- (a) Score card of CAT 2025/IIT-JEE score card (as applicable)
- (b) Certificates & mark sheets of all years / semesters of the qualifying examination;
- (c) Certificate & mark sheets of High School, Secondary School Certificate or equivalent examination;
- (d) Category certificate of GEN-EWS/OBC-NC/SC/ST issued by competent authority on prescribed format by Govt. of India, if applicable.  
(Candidates under OBC-NC and Economically Weaker Sections (EWS) category must submit a copy of valid category certificate as per GOI, issued after 31.03.2025 by a competent authority.)
- (e) Persons with Different Abilities (PWD) candidates must upload the relevant certificate(UDID) from a Govt. Medical Board along with the Application. However, such a candidate shall have to appear before a Medical Board duly constituted by IIT Roorkee for this purpose, if needed.
- (f) Proof of First rank holder/Gold Medalist in qualifying degree (if applicable)
- (g) Proof of Institute/University within the TOP 50 ranks (Overall category) in NIRF in 2025 (If applicable)
- (h) Sponsorship/Experience/No Objection Certificate, if applicable (Annexure-2)
- (i) Proof of annual turnover during the past two years exceeds Rs. Five Crores of parent organization, if applicable
- (j) Passport (applicable for International candidates only)

## **5.3 Admission Offer**

Based on the aggregate performance, a merit list shall be drawn for offering provisional admission to the Program. Provisional admission offers shall be sent by email at the mailing address as given in the application form. This information will also be available on the Institute website.

The candidates offered provisional admission should deposit full fee latest by the date specified in the provisional admission offer letter, failing which their candidature for admission may stand cancelled. A system of registration is followed for all the students joining the Institute. The selected candidates will have to register personally as per the schedule.

#### **5.4 Fee Refund**

No refund of fees will be permissible to the students who get registered for the Program but do not join subsequently or who leave the Program after joining. In such cases, only security and mess balance will be refunded.

In case of withdrawal of admission before registration, the processing fee of Rs. 1000/- will be deducted from the fee deposited by the candidate.

#### **5.5 Admission Offer**

Admission process will be completed through multiple rounds of offer, if required. Candidates need to be prepared with the requisite fee and all necessary documents for registration at a short notice. Information will be updated on the website.

#### **5.6 Cancellation of Admission**

The Institute has the right to cancel at any stage the admission of a candidate who is admitted to a course to which he or she is not entitled being unqualified or ineligible in accordance with the statutes and regulations in force.

Disputes, if any, arising out of or relating to any matter whatsoever concerning admissions to the MBA Program at IITR shall be subject to exclusive jurisdiction of Roorkee.

## **5. DETAILS OF ONLINE APPLICATION SUBMISSION**

---

#### **5.1 How to Apply**

**Before applying, candidates are advised to read the "Information Brochure for MBA Admission 2026" carefully.**

**Candidates must follow the following Steps while applying online Application Form.**

- e) Pay fee online using option "Proceed for Payment"
- f) Download Application Form (Take a print out of the entire file, if required. This printout is NOT to be sent to IIT Roorkee. It is only for candidate's own record purpose)
- g) Candidates will receive one application ID number after submitting the application online. This ID number should be used in all correspondence in future.

**Note: The information in respect of CAT Registration No. and CAT Percentile is to be filled with utmost care, if it is found to be incorrect at any stage, then the application will be cancelled without any further notice.**

Candidates shall be solely responsible for the eligibility, correctness and authenticity of the information / documents provided in the online application. The application is liable to be cancelled in case of false or wrong information.

- 6.3 Online application submitted by the candidates shall be considered final and binding. Requests for making correction/modification/change in the online application shall not be entertained in any case.

- 6.4 The Institute reserves the right to verify the antecedents or documents submitted by the candidate at any time during their period of study. In case it is found that the documents submitted by the candidate are not genuine, then his/her admission shall be terminated, and disciplinary / criminal proceedings will be initiated.

6.5 No request shall be entertained for accepting the application after the last date. IIT Roorkee will not be responsible for technical error while making the online application/ payment of fee.

**Therefore, candidates are advised to submit their application well in advance and not to wait for the last moment.**

6.6 Applications will be scrutinized, relevant documents checked / verified for their authenticity. Candidates are requested to check the information sent by the institute and do the needful, if required. The institute shall not hold the responsibility for the failure of the candidates in timely checking the e-mails/ doing the needful.

All the candidates are requested to mention their operational e-mail ids and contact numbers in the online application form.
