At the outset, the Chairman welcomed all the members, with especial acknowledgement to external members, Mr. Muruganand & Mr. Anupam Singh.

The agenda was then taken up.

Item No. 45.1: To confirm the minutes of 44th meeting of the Building & Works Committee held on 24.03.2021.

No comments were received and the minutes of the 44th meeting of the B&WC as circulated on 06.05.2021 were confirmed.



tem No. 45.2: To receive a report on the action taken to implement the decisions of the 44th meeting of Building & Works Committee held on 24.03.2021 and pending actions on the minutes of the earlier meetings of B&WC.

The B&WC noted the actions taken on various reported items. Suggestions were made for the following item:

39.5: It was felt that an underpass connecting main campus with Niti Nagar Houses may not be required now in view of the reduction in traffic owing to the construction of Roorkee bypass. It was proposed that possibility of construction of a foot over bridge may be explored if users find it useful.

The B&WC also noted the progress, both physical and financial, of various ongoing projects being executed by CPWD (as given in the Appendix in Agenda).

Item No. 45.3: To consider the proposal for construction of a new Building for Mehta Family School of Data Science and Artificial Intelligence at IIT Roorkee.

The B&WC considered the proposal, excluding the cost of furniture, and recommended the same to the FC and BoG at a preliminary cost of Rs.22.50 crore.

Further, it was recommended that for future projects the Institute should empanel experienced structural designers for the evaluation of structural designs undertaken by the Architectural Consultant. The B&WC also ratified the approval accorded by the Director as Chairman B&WC for hiring of a Consultant for the planning and designing of the building.

Item No. 45.4: To consider the proposal for Renovation, Face-lifting & Facade Lighting of the James Thomason Building.

The consultant of the project made a brief presentation before the committee. After due deliberations, while accepting the project report prepared by the consultant, it was decided that the proposed work of renovation and facelifting should also include necessary measures for the structural safety of the building. It was recommended that



the work be executed in a phased manner so that the administrative works of the Sections/Offices occupying this building have minimal disturbance or disruption.

Item No. 45.5: To consider the proposal for construction of a New Hostel (200 DUs) for Married Students' at Niti Nagar area, IIT Roorkee.

The B&WC considered the proposal, excluding the cost of furniture, and recommended the same to the FC and BoG at a preliminary estimated cost of Rs. 51.91 crore.

Item No. 45.6: To consider the proposal for Centralized Airconditioning of the Dining Halls of the Ravindra Bhawan, Govind Bhawan and Azad Bhawan Messes.

The B&WC considered the proposal and recommended the same to the FC and BoG at a preliminary estimated cost of Rs. 6.32 crore.

Item No. 45.7: To consider the revised proposal for Residential accommodation for Faculty and Group-A Officers in Vikas Nagar (Phase-III).

The B&WC considered and approved the revised proposal.

Further, the B&WC recommended to the FC and BoG, the demolition of 9 old houses (7 nos. A1 and 2 nos. A2 category) in order to execute the proposed project.

The meeting ended with a vote of thanks to the Chair.
