## Item No. 85.1: To reconsider the Autumn Semester 2020-21 completion plan for all students (excluding UG I year).

The IAPC in its 95<sup>th</sup> meeting held on 09.12.2020 and 11.12.2020 deliberated upon the proposal to conduct an online End Term Examination (ETE) for all students excluding UG I yr due to non-feasibility to conduct physical ETE in present pandemic scenario. The IAPC suggested few modifications. The modified proposal is placed at **Appendix A**.

The above is submitted for the consideration and approval of the Senate.

#### Proposed Model for Conducting Online Examination for the Autumn Semester 2020-2021 All Students (Excluding UG I Year)

As per the Senate approved Semester Completion Plan for the Autumn Sem 2020-21, the students (excluding UG I Year) are supposed to return to the campus in the month of Jan 2021 to appear in the conventional off-line End Term Examination (ETE)during Jan 20–29, 2021. Since the situation is still not conducive for the mandatory return of all the students to the campus, there is a need to revisit the mode for conducting ETE / schedule of the ETE.

An online examination seems to be the most suitable option available with the institute in the present scenario for all the students (excluding UG I year). At the same time, it is also necessary to ensure the effectiveness and fairness of the online examination. In this regard, the following points are suggested for the completion of **Autumn Sem 2020-21 for all students** (excluding UG I Yr):-

- 1. The End Term Examination (ETE) to be scheduled as per the earlier declared Semester Plan i.e. from Jan 20 to Jan 29, 2021.
- 2. The ETE to be conducted in an inhouse online mode, preferably using MS Forms, Google Forms, Moodle, Open book etc. with appropriate proctoring mechanism using MS Team, Webex, Zoom etc.
- To proctor the exam, students may be advised to turn on the video of their device and one proctor (TA/ Faculty) may be assigned every15-20 students or Tutorial Batches. The course instructor should ensure the fairness of the examination to his/her own satisfaction.
- 4. In order to improve sanctity of the examination, the following ways may be adopted while preparing the question papers:
  - (i) A sufficient number of sets of question papers may be prepared depending on the size of the class.
  - (ii) Each set may have different but equivalent questions.
  - (iii) The sequence of questions in a particular set may be randomized.
  - (iv) The questions can be MCQs and/or subjective type.
  - (v) In MCQ type questions the sequence of options may also be randomized. It may also be asked to write the reason for selecting a particular option. Additionally, if possible, the questions may be opened in batches with time bound validity.

- (vi) All the examinations should be limited to two hour duration only.
- 5. It is important to note that video proctoring may be difficult if the bandwidth is not sufficient to support live camera streaming (say less than 512 kbps). To avoid this, students not having adequate infrastructure can visit and stay at IITR Greater Noida Extension Campus to appear in the online examination.
- 6. Before every examination, the students will be asked to submit an undertaking that "I agree to uphold the highest standards of academic integrity during this online examination. I will neither seek external help from any source or any other examinee, nor provide help to any other examinee appearing in this examination. I understand that any unfair or unethical conduct can lead to disciplinary action against myself".

# Item No. 85.2: To consider the mercy appeal of Mr. Sunil Kumar (En. No.12918025), ex-Ph.D. student, Department of Electrical Engineering., to re-join his Ph.D. program (in the light of the decision of Hon'ble High Court of Uttarakhand).

- (i) Mr. Sunil Kumar was admitted in the Ph.D. program on 06.02.2013 with Institute Assistantship.
- (ii) He changed his status from full-time to part-time to join a job w.e.f. 10.11.2014 and was relieved from IIT Roorkee.
- (iii) Academic registration was cancelled on 12.12.2014 as he failed to submit NOC from his organisation.
- (iv) Got NOC dated 19.6.2020 from his parent organization and requested to IITR to continue his Ph.D. program.

His mercy appeal was discussed in the 40<sup>th</sup> IRC meeting dated 08.08.2020. The IRC did not recommend his mercy appeal. Recommendation of IRC was placed before the Chairman, Senate for consideration and approval on behalf of the Senate. The Chairman Senate, on behalf of the Senate, approved the recommendation of IRC and the decision was intimated to Mr. Sunil Kumar vide letter dated 27.08.2020 (Appendix-A).

Now, the Hon'ble High Court of Uttarakhand, in Writ Petition filed by Mr. Sunil Kumar against IIT Roorkee in 2016 has delivered the following judgement:

"The writ petition is disposed of with liberty to petitioner to make representation to SENATE of IIT Roorkee, through its Registrar, within two weeks from today. If such a representation is made within stipulated period, the Registrar, IIT Roorkee shall place the same before the SENATE in its next meeting and the SENATE shall consider the matter and pass appropriate order, in accordance with law."

On the basis of the decision of the Hon'ble Hon'ble High Court dated 01.09.2020 (Appendix-B), Mr. Sunil Kumar has submitted his representation to the Senate through the Registrar via email dated 07.09.2020 (Appendix-C) to allow him to continue his Ph.D. program.

Mr. Vipul Sharma, Advocate for the respondent.

Heard learned counsel for the parties through video conferencing.

Petitioner was appointed as Assistant Professor in College of Engineering and Technology, Bikaner. Petitioner applied for admission in Ph.D. Course in I.I.T., Roorkee and, after appearing in written test followed by interview, he was declared successful. Thereafter, he applied for NOC to his employer i.e. College of Engineering and Technology, Bikaner, however, NOC was refused.

Petitioner, thereafter, filed a Civil Suit and, pursuant to an interim order passed in the said suit, petitioner was granted NOC provisionally, subject to the condition that, if the President, Governing Council, rejects petitioner's prayer for NOC, then petitioner shall not pursue Ph.D. Course and he will not claim any right based on the provisional NOC. On the strength of provisional NOC, petitioner was given admission in Ph.D. Course by I.I.T. Roorkee.

Learned counsel for the petitioner submits that I.I.T., Roorkee vide order dated 10.11.2014, converted petitioner's Ph.D. Course from full time to part-time, consequently, petitioner resumed his duties in College of Engineering and Technology, Bikaner on 11.11.2014.

It transpires that B.O.G. of College of Engineering & Technology, Bikaner rejected petitioner's request for N.O.C. and, consequently, I.I.T. Roorkee vide order dated

12.12.2014 cancelled enrollment of the petitioner as Research Student. Thus, feeling aggrieved, petitioner approached this Court mainly challenging the cancellation of his enrollment by I.I.T. Roorkee.

Learned counsel for the petitioner had made a statement that College of Engineering & Technology, Bikaner has now been converted into University College of Engineering & Technology, Bikaner and the present employer has granted N.O.C. to the petitioner on 19.06.2020.

Based on the statement made by learned counsel for the petitioner, Mr. Vipul Sharma, learned counsel for the respondent, was asked to get instructions regarding the decision taken by the Institute Research Committee of I.I.T. Roorkee on the NOC issued by the present employer of the petitioner, which was forwarded by Dean, I.I.T. to Institute Research Committee.

Today, on instructions, Mr. Vipul Sharma, Advocate submits that petitioner's request for re-registration as a Ph.D. Scholar was rejected by Institute Research Committee on 08.08.2020 and the said decision of the Institute Research Committee has been placed before SENATE of the Institute and the same shall be considered by the SENATE in the next meeting.

Learned counsel for the petitioner submits that petitioner's research work is nearing completion and he would complete his research within six months and also in view of the fact that petitioner's present employer has already issued N.O.C. in his favour, petitioner may be permitted to make representation to the SENATE and the SENATE be asked to take decision in the matter sympathetically.

Learned counsel for the respondent submits that if petitioner is permitted to make a representation, then the same shall be considered by the SENATE in its next meeting.

Having regard the to facts circumstances of the case, the writ petition is disposed of with liberty to petitioner to make representation to SENATE of I.I.T. Roorkee, through its Registrar, within two weeks from today. If such a representation made within stipulated period, Registrar, I.I.T. Roorkee shall place the same before the SENATE in its next meeting and the SENATE shall consider the matter and pass appropriate order, in accordance with law.

This is in reference to the current mental health status of the student Mr. Praveen Badvath, we would like to share our opinion, which is as follows:

The Student Mr. Praveen Badvath, S/0 Sh. Kishan Naik Badavath, 18 years old boy currently studying in B. Tech Metallurgy and Material Engineering (1<sup>st</sup> year), staying in Chenab Hostel, brought up for consultations and counseling's with the presenting complaints of – difficulty in adjusting with the environment, ideas of being alone, fear of separation and staying away from parents, crying spells, sadness of mood, declining in academics and losing interest in studies, not contacting with others and poor social contacts, restlessness, and impaired socio-occupational functioning's, for last six month, with insidious onset, continuous course, deteriorating progress, with predisposing traits of poor adjustment mechanism with the new surroundings and positive history of adjustment issues followed by psychiatric treatment (attached).

On Mental Status Examination he was found to be well kempt and tidy, voice & speech was normal, motor behavior was restless, affect was anxious, attention was difficult to aroused, and memory was intact, with present orientation, and average Intelligence.

**Impression:** F 43.2 (Adjustment Disorder with predominant disturbance of other emotions)

#### Recommendations:


- Parents need to be communicated about his current health conditions.



The Student Mr. Praveen Badvath, S/O Sh. Kishan Naik Badavath, 18 years old boy currently studying in B. Tech Metallurgy and Material Engineering (1st year), staying in Chenab Hostel, brought up for consultations and counseling's with the presenting complaints of – difficulty in adjusting with the environment, ideas of being alone, fear of separation and staying away from parents, crying spells, sadness of mood, declining in academics and losing interest in studies, not contacting with others and poor social contacts, restlessness, and impaired socio-occupational functioning's, for last six month, with insidious onset, continuous course, deteriorating progress, with predisposing traits of poor adjustment mechanism with the new surroundings and positive history of adjustment issues followed by psychiatric treatment (attached).

On Mental Status Examination he was found to be well kempt and tidy, voice & speech was normal, motor behavior was restless, affect was anxious, attention was difficult to aroused, and memory was intact, with present orientation, and average Intelligence.

- **3**. 
